DESCRIPTION

Barnstorm is ideally suited for use in all phases of hog farm sanitation, including nurseries, farrowing crates, breeding and gestation rooms, loading chutes, animal transport vehicles, footbaths, waterers and feeders, and all areas on the pork production facility.

DIRECTIONS FOR USE

Thoroughly saturate all surfaces with **Barnstorm** at a dilution rate of 1:64 (2 fl. oz. per 1 gal. of water). This product may be applied through high or low pressure spray apparatus or by immersion. Allow the **Barnstorm** solution to remain on surfaces for several minutes or allow to air dry. Rinse surfaces with clean water before reuse.
